



April IRD • Rebecca DeGroot from Houston turned a walking mushroom at the April remote meeting.

A 1.75"x1.75"x3.5" blank was used for the mushroom cap and "stickey chuck"; a 1.75"x1.75"x6" was used for the body; and a .75"x.75"x4-6"

blank for each leg. The leg blank is determined by the length of legs for the mushroom.



A sketch was made to show the initial shape of the mushroom body to get the offcenter effect on the neck. An area was also planned to create "hips" where the legs join the body. The cap sketch shows a V cut made on the underside to define the gill area of the cap.

The body was shaped and the area defined that would be removed with power carving tools. Holes were drilled in the body to accept the legs.

The mushroom cap underside was turned with a gentle bead to define the gills. Then reverse mounted on a "sticky chuck" (loose fitting jam with some double sided tape).



The legs were shaped. It is best to make just a gentle shape where you will cut the leg so that you get a match after it is rotated. Beads and coves and features can be turned above or below the cut area.

The body profile as turned was traced on a piece of paper to define where the cut will be made on the leg. A piece of veneer can be used to strengthen the leg.



The final shaping of the body was done with power carving burrs.

A woodburner with a skew tip was used texture the gills on the mushroom cap.

President's Spin • If you want to REALLY learn something

Learning to use a tool or technique in turning is not always simple. While there are books and videos on most topics these are almost universally introductory level instructions. Even when seeing advanced topics it is generally presenting the highlights, or we would be watching six

hour videos.

An IRD (Interactive Remote Demonstration) is the next step up as a learning tool since you can get in a few questions. And a live class is that much better since you can practice the technique and get feedback. Practice and 'trial and error' will then get you to a level of proficiency. But if you REALLY want to master the topic, try teaching it. When you can show the process to someone else and explain what is happening why things work (or do not work) it takes your understanding of the process to new levels. You can teach it to yourself by writing notes and observations. Better yet is mentoring a friend or club member in the specific technique. If you are up for a bit more effort then do a demonstration for the club, you may learn something new from the questions.

Talking to new woodturners, I often hear how helpful and willing to share the more experienced turners are. This is a good thing on so VERY many levels, so let's keep that going. - **Steve Reynolds**

 - iii. Will attendees need to register before the meeting so that we do not exceed meeting restrictions?

AAW Member Initiated Petitions • Member initiated petitions are a means for every AAW member to bring forward issues that should be considered by all the members. Signatures are being solicited for two member initiated petitions:

- Petition #1: To remove Gregory Schramek from the Board of Directors of the AAW and
- <u>Petition #2: To Reinstate By-Law 5.16(d) that protects the members' fundamental right to attend</u> <u>Board Meetings.</u> (You do not have to be a member of the site to sign the petition. Petition signatures are solicited on the left hand side of the web page.)

Background on each of the petitions can be found at: <u>Member –Initiated Petitions</u>. Links in the document will also take you to the signature page for each of the petitions. Signing the petition is NOT a vote for the petition. It is just your support that the matter should be brought to **all the members for a vote**. Each petition must be individually signed. A qualified petition requires 10% of the general members for removal of a director or change in the by-laws. The AAW has posted information on the <u>petition to remove a director</u>. However, the AAW has not posted any supporting information on the second petition which addresses the board's action that removed your right as a member to attend/participate in their meetings (a right that was established in the by-laws for over 35 years).

When sufficient signatures are obtained and the petitions submitted to the AAW, their board must then notify the membership of the petition, provide a forum on the AAW website for discussion, and establish a ballot for members to register their vote. Members must be notified of the Special meeting (However, with the recent by-law change enacted by only the board, AAW members will NOT be able to participate in the meeting.)
